Medical Waiver in Relation to COVID-19

I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, preschool staff, and other preschool families.

I voluntarily seek services by Butterfly Garden Learning Center, Inc. and acknowledge that I am increasing my risk of exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while at BGLC.

Through the daily health check points, I will attest that myself or members of my family:

- * Are not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- * Have not traveled internationally within the last 14 days.
- * Have not traveled to a highly impacted area within the United States of America in the last 14 days.
- * Do not believe there has been exposure to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- * Have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- * Am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby release and agree to hold Butterfly Garden Learning Center, Inc. harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the school, or that may otherwise arise in any way in connection with any services received from Butterfly Garden Learning Center, Inc. I understand that this release discharges Butterfly Garden Learning Center, Inc. from any liability or claim that I, my heirs, or any personal representatives may have against the school with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Butterfly Garden Learning Center, Inc.
